## Returns & Payments

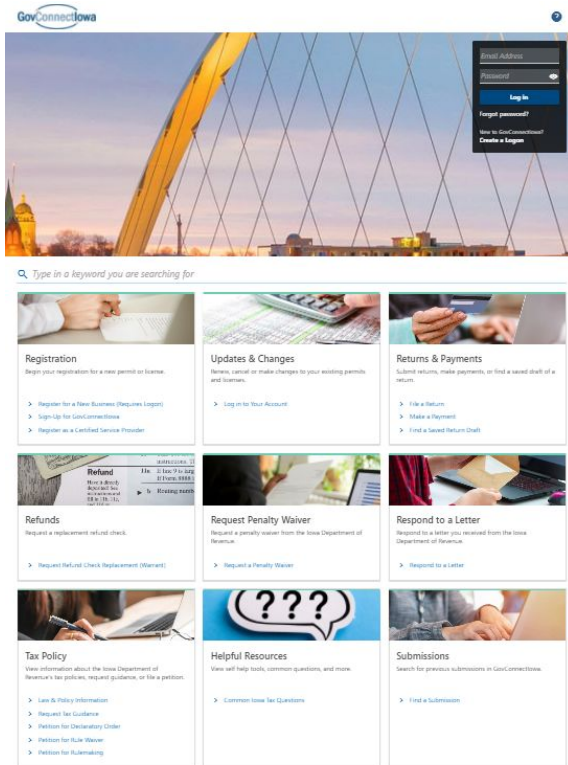
Submit returns, make payments, or find a saved draft of a return.

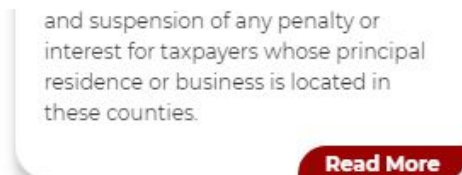
